People in crisis and their family, need somewhere to go to feel safe to decompress from the situation that is currently causing them great stress and anxiety.

Re: Request for Homeless Shelter - Gjoa Haven

Gjoa Haven is in urgent need of more public housing. At present there are 49 families who have applied for housing, many of which have been waiting for several years.

Often families will move from house to house to find a place to stay, and are always at risk of being kicked out. If they have no place to stay, the only option is to move to a cabin which can often be dangerous in the winter months.

Therefore, the lack of a homeless shelter in Gjoa Haven is causing major issues. There are no options for someone who must leave the unit they live in to get away from a partner or someone else they live with.

Kikitak Housing Association urgently requests that an abandoned unit in Gjoa Haven be renovated for the purpose of providing temporary shelter to the community's homeless population.
