## The Order of Nunavut

## **2023 Nomination Form**

- The **Order of Nunavut Act** was passed by the Legislative Assembly in December of 2009 and came into force on January 1, 2010.
- The legislation provides that the objective of the Order is to "honour individuals who have provided an outstanding contribution to the cultural, social or economic well-being of Nunavut."
- Previous recipients of the Order of Nunavut have been recognized for their contributions in a number of fields, including:
  - ✓ Public and community service;
  - ✓ The arts;
  - ✓ Education;
  - ✓ Language promotion;
  - ✓ Spiritual leadership; and
  - ✓ Business and economic development.
- † The Order of Nunavut is the highest honour of Nunavut and takes precedence over all other orders, decorations or medals awarded or conferred by the Government of Nunavut. The inclusion of the Order of Nunavut into the Canadian Honours System was formalized in 2018 by way of a federal Order in Council that was approved by the Governor General.

- The Order of Nunavut Advisory Council recommends individuals for investiture into the Order. The members of the Advisory Council are the Speaker of the Legislative Assembly of Nunavut, the Chief Justice of the Nunavut Court of Justice and the President of Nunavut Tunngavik Incorporated.
- ₽ A maximum of three individuals may be invested into the Order each year. Canadian citizens currently living in Nunavut are eligible for appointment to the Order, as are Canadian citizens who were formerly long-term residents of Nunavut or the area that became Nunavut on April 1, 1999.

- The following are **not** eligible for appointment to the Order while they hold office: Members of the Legislative Assembly of Nunavut; Members of Parliament; mayors and members of municipal councils; judges of any court; members of the Order of Nunavut Advisory Council and the Secretary of the Order of Nunavut Advisory Council.
