The Legislative Assembly and Executive Council Act, S.Nu. 2002, c.5,

Allowances, expenses, benefits

70.01. (1) The Executive Council may establish policies for the payment and recovery of allowances, reimbursement of expenses and provision of benefits to members of the Executive Council that are in addition to those provided for in sections 25 to 33.

Annual report

- (2) The Premier shall, during each fiscal year, cause a report to be laid before the Legislative Assembly
 - (a) setting out any policies made under subsection (1) in the previous fiscal year; and
 - (b) showing the amounts paid by way of allowance, expense or benefit during the previous fiscal year to each person who had been a member of the Executive Council during that fiscal year.

The Ministerial Benefits Policy, Reimbursement For Costs of Temporary Accommodation in Iqaluit (6) provides that Ministers who:

"...continue to maintain a primary residence in a community other than Iqaluit or Apex during the period of their appointment to Cabinet are eligible to claim reimbursement for costs incurred as a result of maintaining a residence in Iqaluit. These include the costs of rent, heat, electricity and utilities for the temporary accommodation that they occupy in Iqaluit, less the rent, if any, received from their primary residence."
