**Declaration of a Local State of Emergency**  
**February 24th, 2021, 8am – March 2<sup>nd</sup>, 2021, 8am**

Due to the longevity of the Public Health Emergency in Arviat the Mayor and Council in an Emergency meeting dated February 23<sup>rd</sup>, 2021 via motion 22321-10 has declared a Local State of Emergency in Arviat for the next 7 days. Mayor and Council will decide on March 1<sup>st</sup> if they will extend the Local State of Emergency for an additional 7 days.

Through the Local State of Emergency Council has declared a Curfew and may place additional restrictions on other programs and services offered in the Hamlet as deemed necessary by Council.

It is very important that the current CPHO's Public Health orders for Arviat and followed very closely. The Local State of Emergency is to assist in making sure we meet all the parts of those orders and additional items deemed necessary by Mayor and Council.

### LOCAL STATE OF EMERGENCY - CURFEW


Through the Local State of Emergency declared by Mayor and Council there is a Curfew that will be in effect starting February 24<sup>th</sup>, 2021 at 10pm.

Each night From February 24<sup>th</sup>, 2021 – March 2<sup>nd</sup>, 2021 from the hours of 10 pm – 6am The following is in place.

- All Retail and Food Service establishments businesses to be closed. All essential service providers can continue as per CPHO Public Health Orders such as Emergency Maintenance, Oil delivery, and Hamlet services.
- No person(s) shall be permitted off their property during this time unless you are in an emergency or an essential worker traveling to or from work.

There will be 24-hour monitoring by the Hamlet's Public Safety officers and 4 additional Officers have been hired to enforce this curfew. Council will announce in the next 48 hours fines that can be given for people not following the curfew. Please understand enforcement is a last resort but it is an option that is available and will be used if necessary.



**LOCAL STATE OF EMERGENCY**  
**ENHANCED COVID RETAIL STORE GUIDELINES**

Through the Local State of Emergency declared by the Mayor and Council there are additional requirements for people shopping at the local retail stores and food establishments to purchase items.

- Only one person per household allowed to shop at the same time.
- Each store will have a person at their entrance to provide masks if you do not already have one and to make sure hand sanitizer is applied before you enter to shop.
- Each store is allowed to have 50% of their maximum capacity as rated by the Fire Marshall's Office.
- Each store will also have their own requirements that they already have in place that must be followed.
